- Being a ticketed only event the likelihood of any prejudice or vilification toward any attendee remains low.
- Additional security personnel have been engaged by Q&Q 2025 in order to assist in the unlikely event a concern is raised.
- Q&Q 2025 Organizers hold a strict zero tolerance policy toward any such behaviour and any such actions will result in immediate eviction from the event.
- Q&Q 2025 will have in excess of 20 volunteers assisting and roaming throughout the event that will be clearly identifiable.
- Senior volunteers will be in direct communication with staff of the Hyatt Regency Portland at the Oregon Convention Center throughout event times. This communication includes but is not limited to front desk staff and the hotel security manager.
- As prescribed in the Hotel Security & Event Planning Guide the local ambulance service is listed as American Medical Response (AMR) who are situated 1 Mile from the hotel with a listed response time of 7 minutes.
- Ticket sales for Q&Q 2025 have been strictly limited to no more than 500.
- Q&Q 2025 volunteers will work continuously throughout the event to ensure thoroughfares do not become congested and overcrowded.
- If necessary Q&Q organizers will ensure author lines are ticketed, this is to be determined closer to the event date based on specific author interest.
- Additional security personnel from United Security will be on hand to assist should they be needed.
- Hyatt Regency Portland at the Oregon Convention Center has a comprehensive fire emergency plan which includes evacuation assembly areas.
- In the event a fire hazard does take place during the event Q&Q organizers will take direct instruction from hotel management and local emergency services and assist where required.







Risk Ranking

- The Higher the risk ranking, the more severe the level of risk
- Higher levels of risk require higher levels of risk control
- Risk control is to lower the risk(s) level to an acceptable level of control, as is reasonably practical.

Basic Risk Management Process

Other Factors to be Considered in Determination of Overall Level of Risk

The higher rating numbers, for both exposure and recurrence ratings; the higher the risk; and this must be considered as a risk level addition that increases the overall risk level.

Risk level increase from higher exposure or recurrence ratings. The higher the level of risk, the more effective the risk controls must be.
